____ 1. **I am the Parent and/or Legal Guardian of the Child/Youth Participant** named above and am executing this form on behalf of the Child/Youth Participant in my capacity as parent and/or guardian and with **the intent that this form be binding on myself and Child/Youth Participant for all legal purposes.**

____ 2. **I Understand** there are inherent **DANGERS, HAZARDS** and **RISKS**, (collectively called **RISKS**) associated with Equine/Animal/Nature Activities and injuries resulting from these **“RISKS”** are a common occurrence.

____ 3. **I Acknowledge** that the Inherent **“RISKS”** of Equine/Animal/Nature Activities mean those **DANGEROUS** conditions which are an integral part of said Activities, **including but not limited to:**

- The propensity of any equine/animal to behave in ways that might result in injury, harm or death to persons on or around them and to potentially collide with, bite or kick other animals, people, or objects.
- The unpredictability of an equine's/animal's reaction to such things as sounds, sudden movement, tremors, vibrations, unfamiliar objects, persons or other animals and hazards such as subsurface objects.

- The potential for other participant(s) to act in a negligent manner that might contribute to injury to themselves or others, such as failing to act within their ability or to maintain control over an equine.

____ 4. **I Freely Accept and Fully Assume All Responsibility** for the Inherent **“RISKS”** and the possibility of personal injury, death, property damage or loss which might result from the Child/Youth being a Participant.

I Acknowledge that it remains my **Sole Responsibility** for the safety of the Child/Youth Participant and for the Child/Youth to Participate within his/her own limits.

In addition to consideration given for the Child/Youth to Participate in Equine/Animal/Nature Activity, I and Child/Youth’s heirs, executors, administrators and assigns (collectively called my “Legal Representatives”) agree

- **To Waive All Claims that I or the Child/Youth Participant might have against the “HOST”;** and
- **To Release the “HOST” from Any and All Liability** for any loss, damages, injury, or expense that I, the Child/Youth Participant or our “Legal Representatives” might suffer as a result of the Child/Youth’s Participation due to any cause **including any NEGLIGENCE ON THE PART OF THE “HOST”;** and
- **To HOLD HARMLESS AND INDEMNIFY THE “HOST”** from any and all liability for property damage or personal injury to the Child/Youth Participant or to any third party which might result from the Child/Youth’s Participation.
